### Registration and Fees:

I, Parent or Legal Guardian agree to return the completed enrollment packet to Camp Krazy Kids prior to your child's first day at camp. Including Emergency form, current health form and payment agreement.

I understand that if my child's enrollment applications are not returned by set dates, my child will not be guaranteed a space in the next enrollment session. I understand enrollment is done on a first come, first serve basis, with priority given to siblings and children enrolling full time. A non-refundable deposit is required to confirm your child's enrollment time of registration.

### Tuition Payment Agreement:

I, Parent or Legal Guardian agree to pay weekly tuition fees for each camp session the Friday before that session begins. Payments can be made weekly by an auto draft from a debit or credit card. Camp Krazy Kids requires a 2-week written notice to cancel or withdraw from camp, guardian will be responsible for full tuition without proper notice.

### Photo Release:

I, Parent or Legal Guardian understand that Camp Krazy Kids uses flyers, holiday cards and other marketing items that may contain pictures. I hereby give my consent for the use of photographs of my child for advertising, publication, promotions, or general purpose for Camp Krazy Kids programs. (Unless otherwise noted in writing by the parent to Director)

### Sunscreen / Insect Repellent:

I, Parent or Legal Guardian, give Camp Krazy Kids permission to apply sunscreen/insect repellent to my child as needed or instructed for the potential of sunburn/insect bites may occur. This will need to be provided by the parent/ legal guardian. If my child does not have his/her own sunscreen/insect repellent, I understand that this is NOT the responsibility of Camp Krazy Kids to supply.

### First Aid/ Emergency Agreement:

I, Parent or Legal Guardian understand and agree to allow the staff at Camp Krazy Kids to give my child basic first aid or CPR as needed and to call for emergency medical transportation "if we determine first aid or emergency transportation is necessary".

### Absence / Illness Agreement:

I, Parent or Legal Guardian understand and agree to call Camp Krazy Kids main telephone 603-228-7529 by 10:00am to inform of my child's absence, illness or late arrival. If my child needs to be dismissed due to sickness I, understand I will need to pick up my child within the hour of communication.

### Open Communication:

I, Parent or Legal Guardian agree that it is the responsibility of both the staff of Camp Krazy Kids and I as the parent/ Legal Guardian to keep an open line of communication with each other while my child is enrolled at Camp Krazy Kids. Small concerns can turn into big problems very quickly if not openly and honestly discussed.
