

Krazy Kids 2023 Ski Program at Pats Peak-Agreement Form

Registration & Fees: I, Parent or Legal Guardian agree to return the completed parent agreement form to the Krazy Kids Ski Program Director prior to the start of the 2023 Ski Program. I understand that if my child's enrollment forms are not returned by set dates, my child will not be guaranteed a space in the program. I understand enrollment is done on a first come, first serve basis, with priority given to siblings.

Photo Release: I, Parent or Legal Guardian understand the Krazy Kids Ski Program uses marketing items that may contain photos. I hereby give my consent for the use of photographs of my child for advertising, publications, promotions or general purpose; (unless otherwise noted in writing by the parent to our Ski Director).

First Aid/Emergency Agreement: I, Parent or Legal Guardian understand and agree to all the staff at Krazy Kids Ski Program to give my child basic first aid or CPR as needed and to call for emergency medical transportation, "if we determine first aid or emergency transportation is necessary."

Mandatory Helmet Policy: I, Parent or Legal Guardian understand that my child must wear a helmet while skiing/snowboarding and/or during any on mountain activity to include; lessons, free ski/snowboard time prior/after lesson. I understand that my child will immediately be removed from the program if this policy is not followed.

Absence/Illness Agreement: I, Parent or Legal Guardian understand and agree to call Krazy Kids at 603-228-7529 by 10am to inform of my child's absence, illness or late arrival. If my child needs to be dismissed due to sickness, I understand I will need to pick up my child at Pats Peak (or Krazy Kids) within the hour of communication.

Open Communication: I Parent/Guardian agree that it is the responsibility of both the staff of Krazy Kids Ski Program and I as the parent/Legal Guardian to keep an open line of communication with each other while my child is enrolled in this Ski Program. After School Pickup: I Parent/Legal Guardian give permission for Krazy Kids Ski Program to pick up my child from their school and transport to and from Pats Peak in Henniker, NH on the following dates: January 3, 10, 17, 24, 31.

Parent/Legal Guardian Pick-up at Krazy Kids: I Parent/Legal Guardian understand it is my responsibility to pick up my child at Krazy Kids, 60 Sheep Davis Road, Pembroke, NH on the following dates at 7:00pm, January 3, 10, 17, 24, 31. If I choose to release my child from Krazy Kids care at Pats Peak, I understand I must sign a waiver releasing my child from their care.

Cancellation Due to Weather: I Parent/Legal Guardian understand it is the decision of the Krazy Kids Ski Program to decide cancellation of transportation to Pats Peak due to weather or any other factors even if Pats Peak does not cancel their lessons.
