Registration and Fees:

I, Parent or Legal Guardian agree to return the completed enrollment packet to Camp Krazy Kids prior to your child's first day at camp. Including Emergency form, current health form and payment agreement.

I understand that if my child's enrollment applications are not returned by set dates, my child will not be guaranteed a space in the next enrollment session. I understand enrollment is done on a first come, first serve basis, with priority given to siblings and children enrolling full time. A non-refundable deposit is required to confirm your child's enrollment time of registration.

Tuition Payment Agreement:

I, Parent or Legal Guardian agree to pay weekly tuition fees for each camp session the Friday before that session begins. Payments can be made weekly by an auto draft from a debit or credit card. Camp Krazy Kids requires a 2-week written notice to cancel or withdraw from camp, guardian will be responsible for full tuition without proper notice.

Photo Release:

I hereby give my consent for the use of photographs of my child for advertising, publication, promotions, or general purpose for Camp Krazy Kids programs. Sunscreen / Insect Repellent:
